

## RESOLUTION NO. 2023-07

### A RESOLUTION CERTIFYING THE CANVASS OF THE 2023 GENERAL MUNICIPAL ELECTION FOR THE CITY OF KAMAS

A Resolution of the City Council of Kamas City, canvassing the returns of the General Municipal Election held on November 21, 2023 for the position of three City Council seats and declaring the result thereof.

**WHEREAS**, pursuant to Utah Code Ann. § 20A-4-301(2)(a), the Mayor and the Municipal Legislative Body constitutes the Board of Canvassers of the City of Kamas;

**WHEREAS**, on December 5, 2023, the Board met to canvass the election returns of the 2023 City of Kamas General Municipal Election held November 21, 2023;

**WHEREAS** the election returns have been received and counted by the Summit County Clerk's Office; and

**WHEREAS** the Board publicly canvassed the returns and determined the vote for each candidate;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Canvassers of the City of Kamas, Utah, as follows:

**Section 1.** The City Council, of Kamas City, (The City), called an Election and directed that it be held on November 21, 2023 as per Utah State Law, for the purpose of electing three City Council seats to the City for a term of four years each (the Election).

**Section 2.** The Mayor and the City Council, acting as the Board of Canvassers, has reviewed all matters and action taken relating to the Election and is ready to declare the results thereof.

**Section 3.** Pursuant to the canvass of election returns, the Board finds that the following votes were cast by the qualified voters of The City who voted in the Election:
